RULES AND OPTIONAL SERVICES

ITEM 752-A

DELIVERY SERVICE TO MINES OR QUARRIES

Shipments delivered to the facilities of mines or quarries, including the entire property upon which any pit, excavation shaft or deposit, warehouse, supply house, tipple, etc., at which coal, ore or minerals are, have been or will be extracted, will be subject to the following charges, in addition to all other applicable charges:

- Delivery to points listed in NOTE A.....\$ 75.00 per shipment
Delivery to all other points.....\$150.00 per shipment

NOTE A-Points covered by Zip Codes 25035, 25075, 25130, 25204, 25205 and 25208.

ITEM 752-1

PICKUP AND DELIVERY SERVICE AT EXPOSITION CENTERS

Shipments picked up or delivered at the facilities of a Convention or Exposition center will be subject to a minimum charge based on current ODFL 559 series base rates, at the actual NMFC class of the shipment, less a 50% discount, but not less than \$250.00 per shipment.

ITEM 752-2

DELIVERY SERVICE TO FAIRS OR TRAVELING SHOWS

A charge of \$85.00 per shipment, or per vehicle if more than one vehicle is required to deliver the shipment, in addition to all other applicable charges, will be assessed against the party responsible for payment of the line haul charges on shipments delivered to the facilities of Fairs or Traveling Shows. All shipments consigned to facilities of Fairs or Traveling Shows must move prepaid.

ITEM 752-3-A

PICKUP AND DELIVERY SERVICE AFTER BUSINESS HOURS

- 1. When pickup or delivery is required between the hours of 8 P.M. and 6 A.M. the following charges will apply.

8 P.M. to 9 P.M. \$ 75.00
9 P.M. to 4 A.M. \$ 100.00
4 A.M. to 6 A.M. \$ 90.00

- 2. Shipments shall be subject to detention charges as follows:

FREE TIME:

(a) The free time per vehicle shall be as follows:

7,500 - 9,999 lbs. 120 min. 40,000 lbs. or more 360 min.

ITEM 752-3-A

PICKUP AND DELIVERY SERVICE AFTER BUSINESS HOURS

2. Shipments shall be subject to detention charges as follows:  
FREE TIME:
    - (b) Cancelled.
    - (c) When single or multiple shipments weighing less than 10,000 lbs. each exceed the carrying capacity of one vehicle, free time for each vehicle shall be computed separately.
  3. DETENTION CHARGES:
    - (a) The charge for the delay of each vehicle beyond the free time will be:  
\$24.00 for each following 15 minute period or fraction thereof.
    - (b) When there is more than one payor, charges will be prorated on the basis of the weight of each individual shipment.
  4. The charges provided in this item will be assessed against the payor of the freight charges unless payment has been guaranteed to the satisfaction of the carrier by the consignor, consignee or a third party.

ITEM 752-4

DELIVERY SERVICE - AT NEW JERSEY STATE PRISON, TRENTON, NJ

Shipments delivered to the New Jersey State Prison, Trenton, NJ will be assessed an additional delivery charge of:  
\$250.00,  
in lieu of charges in Item 753-4 (Pickup and Delivery Service at Secured or Limited Access Locations) in addition to all other applicable charges.

ITEM 752-5

DELIVERY SERVICE AFTER BUSINESS HOURS - HOME DEPOT

An additional charge of:  
\$90.00 per shipment,  
will be assessed to the shipper on prepaid shipments when carrier is required to deliver between the hours of 8:00 P.M. and 6:00 A.M. Should carrier be required to deliver shipments on Saturday, Sunday or a Holiday between the hours of 8:00 P.M. and 6:00 A.M., the charge will be:  
\$150.00 per shipment.  
The charges will apply in lieu of charges shown in Item 752-3 and Item 754.

ITEM 752-6

DELIVERY SERVICE TO WAL-MART DISTRIBUTION CENTERS

All shipments to Wal-Mart Distribution Centers must be palletized and shrink wrapped for unattended unloading at the Wal-Mart Distribution Center. Shipments accepted as pieces tendered on pallets and transported on pallets through the ODFL system will be tendered for delivery on pallets with shrink wrap intact. Subsequent shortage claims will not be honored if shrink wrap was intact and the correct number of pallets was delivered to the Wal-Mart Distribution Center.
