APPLICATION OF TARIFF

1. Except as otherwise provided, provisions of this tariff apply only on minimum charge, LTL or AQ class rated interstate and intrastate shipments handled direct by ODFL and subject to rates in ODFL 559/555 Series. Also applies on direct shipments between points in the USA and points in Canada, subject to rates in ODFL 505 series. Provisions of this tariff will apply in connection with rates in other tariffs only when such other tariffs are specifically identified in individual items herein.
2. Discounts/Allowances named in this tariff apply only on applicable classes as named in the NMFC, except as noted.
3. When discount/allowance provisions are published for the consignor, consignee and paying party of a shipment, provisions to apply will be those applicable to the payor of the freight charges.
4. The absence of transportation activity with a specific account for a period of six (6) months will be construed by carrier to mean published provisions are obsolete and may result in the cancellation of said provisions.
