ITEM 120 — CANCELLATION OF ITEMS

As this tariff is supplemented, numbered items with letter suffixes cancel, except as otherwise specifically indicated, correspondingly numbered items in the original tariff or in a prior supplement. Letter suffixes will be used in alphabetical sequence starting with A. Example: Items 445—A cancels Item 445 and Item 365-B, cancels Item 365-A which cancelled Item 365. If the new Item provides a specific cancellation of prior issue or issues, this rule is not applicable.

ITEM 130 — PARTICIPATION IN TARIFF

Request for participation in this tariff must be submitted to ODFL's corporate office for approval. Once approved, Customer will receive confirmation of participation and rates will be made available to customer.

ITEM 150 — CARRIER LIABILITY

All shipments moving under these rates are subject to ODFL 100 series, Additional Services and Rules Tariff, item 594, Maximum Carrier Cargo Liability.

Optional Higher Level Optional Higher Level of Carrier Cargo Liability may be purchased per ODFL 100 Series, Item 574.

ITEM 151 — APPLICATION OF RATES

- 1. Cubic meters or cubic feet must be shown on the bill of lading.
- 2. Weight must be shown on the bill of lading stated as either pounds or kilograms.
- 3. Carrier may choose at its discretion to honor the estimate if reference number is listed on original bill of lading.
- 4. If key variables in the "rate estimate" are found to have changed, such as zip codes, weight, cube, or accessorial charges, such shipment will be rerated with the new information as provided in this tariff.
- 5. Rates will apply on the total gross weight of the shipment as tendered to carrier.
- 6. Rates applies only within the 48 Contiguous States and between the 48 Contiguous States and Canada.
- 7. Rates are subject to change without prior notice.

ITEM 152 — NON-APPLICATION OF TARIFF

- 1. Rates do not apply on shipments subject to pallet exchange or return.
- 2. Bills of lading that are not noted with the required information, as stated in Item 151, sub 1, shall be rated per ODFL 602 series, Discount Tariff.
- 3. Rates do not apply on shipments containing used or new tires.

ITEM 565 — FRACTIONS OF CUBIC METERS OR CUBIC FEET

In determining the number of cubic meters to be charged, ODFL shall use the cube information provided on the bill of lading to determine the number of cubic meters to use. However, ODFL reserves the right to measure and correct the cubic meters based on its physical examination of the freight. Charges may not be assessed using fractions, such as 3.2 cubic meters. All fractions will be rounded UP to the next whole number.

ITEM 870 — RULES, REFERENCE TO

When reference is made to a tariff, item, rule note or page, such reference also will embrace amendments and supplements thereto, or successive issues of said tariff, item, rule, note or page.

ITEM 880 — NON-APPLICATION OF RULES LISTED IN ODFL 100 SERIES

Shipments rated from this tariff shall not be subject to ODFL 100, Item 610-1 (Minimum Charge for Low Density Freight).
