**ITEM 150
APPLICATION OF TARIFF**

The request for such service will be subject to the rules, restrictions, discounts, minimum charges and other provisions contained herein.

**ITEM 150-1
APPLICATION OF TARIFF – WHITE GLOVE SERVICE**

The provisions of White Glove service apply only when such services requested herein is moving prepaid by the consignor, consignee or third party payor. The request for such service will be subject to the rules, restrictions, discounts, minimum charges and other provisions contained herein.

Provisions of this service **shall NOT apply on:**

- i. Collect shipments
- ii. COD shipments
- iii. **Residential** Delivery or Pick up shipments

**ITEM 160
 RESTRICTED COMMODITIES**

Speed Service - On Demand will NOT apply on shipments of the following commodities:

- i. Perishable Goods
- ii. Prohibited or Restricted Articles as named in Item 780 of Rules Tariff ODFL 100 Series.

**ITEM 165
 RESTRICTED PICK UPS AND DELIVERIES**

Speed Service - On Demand will NOT apply on shipments requiring delivery or pick ups at the following:

- Points in MN, ND and SD served by agent Magnum LTL, Inc. (MGUL)
- Points in MI and WI served by agent U S SPECIAL DELIVERY INC (UPPN)
- Partner/Interline points

Any service failure from or to Canada zips named here in due to shipment(s) being delayed by Customs or other government agencies, Carrier shall remove all charges for Service On Demand from customers invoice and apply otherwise applicable LTL charges. Normal LTL charges that are otherwise applicable will not be waived on shipment conditions noted herein.

**ITEM 170
RESTRICTED SERVICES**

Speed Service - On Demand **will NOT apply on shipments** requiring the following services:

- i. Collect on Delivery (C.O.D.)
- ii. Delivery to points subject to Arbitrary Charges as named in Items 352-1, 352-5 (previously 751) and 352-10 (previously 751-5) of ODFL 100 Rules Tariff (www.odfl.com/Tariffs).
- iii. In Bond Shipments

Carrier is not responsible for delays in service due to the final consignees request for appointments, notifications, or other delays imposed on the delivering carrier.

**ITEM 175
FORCE MAJEURE**

Speed Service - On Demand described in this tariff will become void when conditions beyond carriers control and without its fault or negligence arise, including, without limiting and generality of the foregoing; acts of God or the public enemy, fire or explosion, flood, actions of the elements, war, riots, embargoes, quarantine, strikes, lockouts, disputes with workmen or other labor disturbances, acts or requests of any governmental authority, data communication or hardware failure beyond carriers control, or any cause beyond its control, whether or not similar to the foregoing.

**ITEM 500
SPEED SERVICE - ON DEMAND**

Requests for Speed Service - On Demand must be made as follows:

1. Call an OD EXPEDITED COORDINATOR at **1-866-637-7333 (866-ODSPEED)**. No other person is authorized to Commit ODFL to On-Demand Service and Price levels.
2. OD EXPEDITED COORDINATOR will negotiate service and price.
3. **ON PREPAID SHIPMENTS PAID BY THE SHIPPER:** OD EXPEDITED COORDINATOR will advise shipper of specific information that **MUST** appear on the Bill of Lading including the Pro Number assigned to the shipment.

ON COLLECT SHIPMENTS and THIRD PARTY BILLING SHIPMENTS: OD EXPEDITED COORDINATOR will contact the payer of charges to verify service and price levels. OD EXPEDITED COORDINATOR will then advise specific information that **MUST** appear on the Bill of Lading including the Pro Number assigned to the shipment.

5. Allowances/Incentives or any Other Pricing Provisions contained in any tariff or contract schedule shall not apply on shipments when Speed Service on Demand is requested and utilized by customer.

**ITEM 510
DEFAULT CHARGES**

Customers shall be charged off the ODFL 559/505 current series of base rates less a 20% discount, subject to the following minimum charges:

Delivery between 12:00 p.m. and 5:00 p.m.	\$350.00
7:00 am. To 12:00 p.m. and less than 30 miles from the delivering terminal	\$475.00
7:00 a.m. to 12:00 p.m. and between 30 to 60 miles from the delivering terminal	\$625.00
7:00 a.m. to 12:00 p.m. and 61 miles or more from delivering terminal	\$3.00 per round trip mile, subject to a minimum of \$700.00
8:00 p.m. to 7:00 a.m.	\$1050.00

Depending on the shipment characteristics and the delivery and service requirements, the ODFL Speed Service may quote charges that differ from this default pricing (such pricing must be authorized in writing by both parties prior to movement).

**ITEM 520
ADJUSTMENT OF FREIGHT CHARGES FOR SERVICE FAILURE**

If customer makes a written claim to ODFL within 30 days of delivery for a failure to perform a time specific delivery that exceeds one (1) hour from the committed delivery time, ODFL will revert applicable Speed Service charges to the payor's non Speed Service published rates.

When ODFL purchased transportation from an outside source and failure to perform time specific delivery that exceeds 1 hour from the committed delivery time, ODFL will reduce applicable Speed Service Charge(s) by 20% in lieu of reverting to non Speed Service published rates. Purchased transportation includes On-Demand Airfreight shipments governed by ODFL 665, reference Item 2640 in Tariff ODFL 665 (<http://www.odfl.com/Content/otherTariffRules.faces>) for time specific airfreight shipments.

If the Speed Service charges have been paid, a refund will be issued for the difference to the claimant. If failure is due to conditions outlined in ITEM 175 - FORCE MAJEURE, no refund or reduction shall apply.

**ITEM 540
CANCELLATION OF PICKUP**

When ODFL has been requested to provide Speed Service on Demand and the shipment/request is subsequently cancelled, the following will apply.

1. Once the OD EXPEDITED COORDINATOR has received confirmation and acceptance whether verbal or written of price and service from the authorized Payor, ODFL will immediately make arrangements for servicing the request. ODFL will grant a grace period of 15 minutes from receipt of acceptance for cancellation of the service, when freight is moving within the OD Network or with a partner carrier, without charge or penalty.
2. After the expiration of the fifteen (15) minute grace period and Payor requests cancellation of the service, ODFL shall charge a minimum of \$300.00 to the Payor to offset any and all out-of-pocket expense charged by third parties to ODFL or incurred for servicing the requested shipment.

**ITEM 564
FAILURE TO MAKE TIMELY PAYMENT OF CHARGES**

Failure to make payment of charges for services performed hereunder within a period of **42** calendar days from the original invoice due date will result in penalties and charges provided in **Item 564** of ODFL Rules Tariff 100 series.

ITEM 821
BLIND SHIPMENT

A blind shipment occurs when ODFL is requested or required to act as the intermediary in instances when the shipper is unaware of the actual destination and/or the consignee is unaware of the actual origin. The requestor of this service must be the owner of the goods or someone authorized to act on behalf of the owner of the goods.

1. Prior to pick up, Carrier must receive from the requestor the "Blind Shipment Coordination" form (<http://www.odfl.com/fillprintforms/BlindShipmentForm.pdf>) and an amended bill of lading, which should state the information to keep the shipment blind.
2. If the "Blind Shipment Coordination" form is not received by Carrier prior to pick up, the request will be handled as a reconsignment subject to the provisions of Item 820. Provisions and charges for both blind shipment and reconsignment (See Item 820) will apply.
3. A charge of \$250.00 per shipment, in addition to all other applicable charges, will apply.
4. Carrier must be satisfied that the requestor has the legal authority to control the shipment.
5. Carrier will accept the shipment when tendered by the party in possession and issue a bill of lading to move the shipment to requestor at Carrier's origin terminal. The bill of lading received from the requestor will apply from Carrier's origin terminal to the final consignee and destination.
6. Charges for this service and applicable line haul charges must be billed prepaid, and paid by the party requesting the service.
7. Carrier will make a diligent effort to execute a request for blind shipment, but will not be responsible if such service cannot be effected.
